WHEREAS, I, Josef M. NOW, THEREFORE, for good and valuable consideration furnished by Assignee to me, receipt and sufficiency of which I hereby acknowledge, I hereby, without reservations:

1. Assign, transfer, grant, convey and relinquishes to Assignee the entire right, title, and interest in and to the '222 Patent and the '891 Patent, the inventions and discoveries claimed therein, all foreign patents that rely on said '222 and '891 Patents for priority, any other patent application, including all divisional, renewal, substitute, and continuation applications, directed to the inventions and discoveries claimed therein, and all Letters Patent of the United States of America that may be granted thereon, and all reissues, reexaminations, and extensions thereof, and all rights to claim priority on the basis of such application, and all applications for Letters Patent that may be filed for the inventions and discoveries claimed therein in any foreign country and all Letters Patent that may be granted on the inventions and discoveries claimed therein in any foreign country, and all extensions, renewals, continuations and reissues thereof, including but

not limited to WO 9203987, WO 9210145, European Patents EP 547,181 B1 entitled "An improved dental attachment structure," and EP 560,889 B1 entitled "Adjustable dental implant system," including any national patents derived therefrom, German Patents DE 691 29 039 and DE 691 21 207, and Japanese Patents JP 3297435, JP 6505645, JP 6500487 and JP 3124293, together with all accrued causes of action for damages for infringement (altogether "the Patents").

2. Warrant that, with respect to any person or entity other than Sterngold, I own all right, title, and interest in and to the Patents; that I have good right to assign the same to Assignee without encumbrance; that I have not conveyed to others any right, title, or interest in and to the Patents, or any license to use the same or to make, use, or sell anything embodying or utilizing any of the Patents; and that, with respect to any person or entity other than Sterngold, I am aware of no claim to the contrary.


3. Authorize Assignee to file patent applications in any or all countries for any or all of said inventions and discoveries claimed in the patents in my name or in the name of Assignee or otherwise as Assignee may deem advisable, under an International Convention or otherwise.

4. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of any foreign country to issue or transfer all said Letters Patents to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.

5. Bind my heirs, legal representatives, and assigns, as well as myself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to me or them, all acts reasonably serving to assure that the Patents shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by me, my heirs, legal representatives, and assigns if this assignment had not been made; and

particularly to execute and deliver to Assignee all lawful patent documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to me relating to the Patents or the history thereof; to furnish Assignee with any and all documents, photographs, models, samples, and other physical exhibits in my possession and control or in the possession and control of my heirs, legal representatives, or assigns which may be useful for establishing the facts of my conceptions, disclosures, and reduction to practice of said inventions and discoveries; to testify to the same in any interference, arbitration, or litigation; and generally do everything possible to aid Assignee, its successors and assigns, to obtain and enforce proper patent protection for the invention and discoveries in the United States of America and any foreign country.
