Exhibits B-E hereto, and in and to any and all patents granted on any of said U.S. or foreign applications to the full end of the terms for which said patents may be granted; and

(4) in and to any patent applications filed under any International Convention claiming priority from any of the patent applications listed in Exhibits A-E hereto. Assignor agrees that any patent applications of any foreign countries which may be filed pursuant to this Agreement shall be filed in the name of the Assignee and may claim to priority from any of said United States or foreign applications listed in Exhibits A-E hereto.

And Assignor hereby also agrees that it will, upon demand of Assignee, its successors or assigns, and without further consideration to Assignor, execute any and all papers that may be necessary, or deemed by Assignee, its successors or assigns to be necessary, to a complete fulfillment of the intent and purposes of this Assignment.

And the Commissioner of Patents and Trademarks of the United States is hereby authorized and requested to issue to the Assignee any United States patent that may issue on any patent application included in this Assignment.

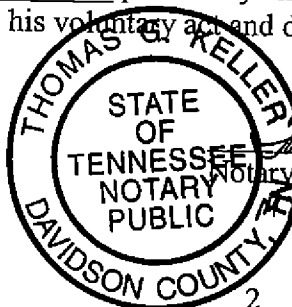
