ASSIGNMENT

WHEREAS, **HANOVER COMPRESSION LIMITED PARTNERSHIP** ("Assignor") and **CCT TECHNOLOGY, L.L.C.**, an Oklahoma limited liability company with principal offices located at 6237 S. SELL, ASSIGN AND TRANSFER to Assignee, the entire right, title and interest for the United States and all foreign countries, in and to any and all improvements which are disclosed in United States Letters Patent Nos. 5,957,220 and 6,047,778, each entitled "Percussion Drill Assembly," (collectively, the "**Assigned Patents**") together with all divisional, continuing, substitute, renewal, reissue and other applications for letters patent which have been or shall be filed in the United States and/or in any or all foreign countries on any of the inventions, ideas, concepts, designs and/or improvements thereof described in or covered by the Assigned Patents; all original and reissued patents which have been or shall be issued in the United States and all foreign countries on such improvements; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application in the United States, and the right to bring suit for past infringements of the Assigned Patents; and assigns to CCT all of its right, title and interest in and to claims described in expired U.S. Patent No. 5,662,180, entitled "Percussion Drill Assembly" (the "**Expired Patent**"), with any rights to seek the reinstatement thereof as may be available to CCT, which Expired Patent is, however, expressly not an Assigned Patent hereunder

SELL, ASSIGN AND TRANSFER to Assignee the entire right, title and interest for the United States and all foreign countries, in and to any and all inventions, ideas, concepts, designs and/or improvements which are disclosed in the application for United States Letters Patent, entitled "Drilling System," Application Serial No. 10/733,171, filed December 11, 2003 (the "**Pending Application**"), such applications and all provisional, non-provisional, divisional, continuing, substitute, renewal, reissue and all other applications for patent which have been or shall be filed in the United States and all foreign countries on any of such improvements; all original and reissued patents which have been or shall be issued in the United States and all foreign countries on such Pending Application; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application in the United States;

AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on such improvements to the Assignee;

WARRANT AND COVENANT that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others

by the undersigned, and that the full right to convey the same as herein expressed is possessed by Assignor;


