ASSIGNMENT

WHEREAS, We, ERAN PISEK, resident of Plano, Collin County, Texas, citizen of Israel, JASMIN OZ, resident of Plano, Collin County, Texas, citizen of Israel and Switzerland, and YAN WANG, resident of Plano, Collin County, Texas, citizen of China, have invented certain new and useful improvements in a "RECONFIGURABLE INTERCONNECT FOR USE IN SOFTWARE-DEFINED RADIO SYSTEMS" disclosed in an application for United States Letters Patent (Application No. _____, filed _____), said application having been executed concurrently herewith;

ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.
