Patent Assignment

In the event of any application (including, but not limited to the Patent Applications) or Letters Patent assigned herein becomes involved in interference, Assignor shall cooperate with Assignee in such interference. Assignor hereby covenants that no assignment, sale, agreement, license or encumbrance has been or will be made or entered into which would conflict with this Assignment. Assignor further covenants that it will perform any further acts and execute and deliver any other documents that may be reasonably necessary to carry out the provisions of this Assignment.

3. Governing Law. This Assignment shall be construed and interpreted in accordance with, and all actions arising hereunder shall be governed by, the laws of the State of Indiana, excluding any conflict of law or choice of law provisions that may refer construction or interpretation of this Assignment to the law of another jurisdiction.
