CAPRICORN NEWELL UK (registered number 655647) of Wear Glass Works, Sunderland, Tyne & Wear, SR4 6EB, United Kingdom (hereinafter called "the Assignor") of the first part, and

WHEREAS the Assignee has requested that the Assignor enters into this further deed of assignment in respect of the Scheduled Intellectual Property on the terms hereof.


NOW THIS DEED WITNESSETH as follows:-

2. The Assignor undertakes at the request and expense of the Assignee to bring into effect or do all acts and execute all documents, including any recordable assignment, which may be necessary to confirm the title of the Assignee to the rights assigned under this Deed.


