## PATENT RELEASE

This PATENT RELEASE is made as of October 19, 2005, by BANK OF AMERICA, N.A., as Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and ANDA, INC., ANDRX CORPORATION, ANDRX LABS, LLC, ANDRX LABORATORIES, INC., ANDRX LABS, INC., ANDRX PHARMACEUTICALS, LLC, CYBEAR, LLC, and MEDICONSULT.COM, INC., (collectively, "Grantors," and each, individually, a "Grantor"), entered into that certain Patent and Trademark Security Agreement dated as of December 30, 2002 (the "Patent and Trademark Security Agreement"; the capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Patent and Trademark Security Agreement), pursuant to which Grantors granted a security interest to the Agent in, among other things, the Patents set forth on Schedule 1 attached hereto; and

WHEREAS, the Agent and ANDA, INC., ANDRX LABS, LLC, ANDRX PHARMACEUTICALS, LLC, have entered into a Supplemental Patent and Trademark Security Agreement dated as of November 7, 2003 ("the Supplemental Agreement") pursuant to which a security interest to the Agent in, among other things, the Patents set forth on Schedule 2 attached hereto; and

WHEREAS, the Agent and ANDA, INC., ANDRX LABS, LLC, ANDRX PHARMACEUTICALS, LLC, and RXAPS, INC. have entered into a Second Supplemental Patent and Trademark Security Agreement dated as of April 1, 2004 (the "Second Supplemental Agreement"), pursuant to which Grantors granted a security interest to the Agent in, among other things, Patents set forth on Schedule 3 attached hereto; and

WHEREAS, the Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 6, 2003, at Reel 013767, Frame 0753; and

WHEREAS, the Supplemental Agreement was recorded with the United States Patent and Trademark Office on November 10, 2003, at Reel 014683, Frame 0075; and

WHEREAS, Second Supplemental Agreement was recorded with the United States Patent and Trademark Office on January 25, 2005, at Reel 016180, Frame 0092; and

WHEREAS, the obligations underlying the security interests are no longer owed, and Agent no longer has no further interest in the Patents and the other collateral described in the Patent and Trademark Security Agreement, the Supplemental Agreement and the Second Supplemental Agreement; and

WHEREAS, Grantors have requested the Agent release its lien on the Patents and reassign the same to Grantors.
