

**ASSIGNMENT AND AGREEMENT**

WHEREAS, Jeong-Gaun LEE (hereinafter referred to singly and collectively as "ASSIGNORS") have invented a certain invention entitled **BACKLIGHT ASSEMBLY FOR LIQUID CRYSTAL DISPLAY DEVICE** for which an application for United States Letters Patent was filed on \_\_\_\_\_ accorded as U.S. Application No. \_\_\_\_\_ or is concurrently filed herewith; and

ASSIGNORS HEREBY AGREE (a) to communicate to ASSIGNEE, its successors and assigns, or their representatives or agents, all facts and information known or available to ASSIGNORS respecting said invention or inventions, improvements, and modifications including evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.
