PATENT ASSIGNMENT

THIS AGREEMENT made the 18th day of August, 2005 by and between **BRUCE SZEMORE, JR. GOLF DESIGN, LLC**, a Michigan limited liability company ("Assignor"), and **AS DESIGNS, LLC** ("Assignee").

WHEREAS, Assignor is the registered owner/assignee in all of the intellectual property rights in and to original works of authorship in the nature of a golf putter head (the "Golf Putter Head") and a golf putter head with a checkerboard face (the "Checkerboard Face"), respectively;

WHEREAS, Assignor is the owner/assignee of each of the issued patent registration(s) and pending patent application(s) listed on the attached Schedule A which relate to the Golf Putter Head and the Checkerboard Face;

WHEREAS, Assignee is engaged in the business of golf equipment design; and

WHEREAS, Assignor desires to sell, and Assignee desires to purchase all of Assignor's right, title and interest in and to the inventions, registration(s) and application(s) listed on Schedule A and any patents that may issue therefrom in the United States or any other countries, including the right to sue for past infringements.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. Assignment. Assignor does hereby sell, assign and convey unto Assignee all right, title and interest in and to the inventions, registration(s) and application(s) listed on Schedule A and any patents that may issue therefrom in the United States or any other countries, including the right to sue for past infringements.

2. Further Assurances. Assignor further covenants that Assignor will (i) execute any additional documents or instruments and will do any and all other things as requested by Assignee to more effectively vest title to the intellectual property described herein to Assignee, (ii) upon Assignee's request, provide Assignee promptly with all pertinent facts and documents relating to the inventions and patent applications and legal equivalents as may be known and accessible to Assignor, and (iii) testify as to the same in any litigation or proceeding related thereto and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, and issue said patent application and enforce any patents issuing thereon which may be necessary or desirable to carry out the purposes thereof.

3. Governing Law and Venue. This Agreement shall be governed by the laws of the Commonwealth of Pennsylvania, without regard to its conflicts of laws principles. In the event that a dispute arises between the parties hereto as to any matter relating to this Agreement, such dispute shall be resolved by the parties in the federal or state courts located in Allegheny County, Pennsylvania. The parties hereby irrevocably and unconditionally consent to the jurisdiction of those courts set forth in the immediately preceding sentence and hereby irrevocably and unconditionally waive: (i) any defense of an inconvenient forum to the maintenance of any action or proceeding in any such court; (ii) any objection to venue with respect to any such

action or proceeding in any such court; and (iii) any defense of lack of personal jurisdiction on account of the place of resident or domicile of the parties.

4. Binding Effect. This Agreement and all of the terms and provisions hereof shall be binding upon the parties and their respective successors and assigns.

5. Severability. In the event that any provision of this Agreement is held invalid by a court of competent jurisdiction, such holding shall not affect in any manner the validity of the other provisions.

6. Counterparts. This Agreement may be executed in any number of counterparts, each of which shall be an original, but all of which together shall comprise one and the same instrument.

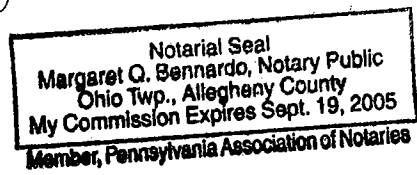
