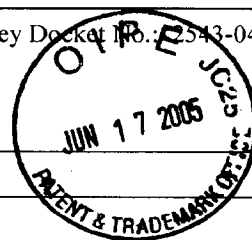

AND ASSIGNOR hereby agrees to execute any papers for ASSIGNEE, its successors, assigns and legal representatives, deemed essential by ASSIGNEE to ASSIGNEE'S full protection and title in and to the invention hereby transferred.

ASSIGNOR furthermore agrees, without further remuneration, to execute any and all papers requested by ASSIGNEE, its successors, assigns and legal representatives, for the filing and granting of foreign applications and the perfecting of title thereto in ASSIGNEE.

ASSIGNOR hereby authorizes Davidson Berquist Jackson & Gowdey LLP to insert hereon any further identification necessary or desirable for recordation of this document.
