ASSIGNMENT OF UNITED STATES PATENT APPLICATION


WHEREAS, we, **Malon S. Updike, Bradley L. Lozier, and John D. Morgan**, of Dayton, OH, Centerville, OH and Charlotte, NC, respectively, have invented certain new and useful improvements in **METHOD OF OPERATING AN IMAGE-BASED SELF-SERVICE CHECK DEPOSITING TERMINAL IN RESPONSE TO A FAULT CONDITION**, Docket No. **12095.10**, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and




