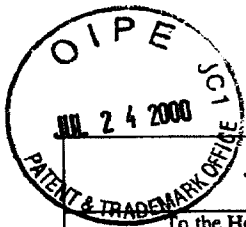

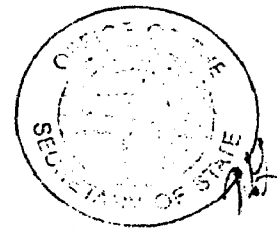
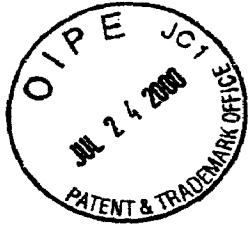

- 2. Article I of the Articles of Incorporation of the corporation is amended to read as follows:


