ASSIGNMENT

WHEREAS, we, Ruth A. Frazer, a citizen of the United States of America and a resident of Camp Hill, Pennsylvania; Gary L. representatives.

We, individually and collectively, hereby further agree to communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries. We further represent that we own the rights being conveyed by this Assignment and have not previously encumbered or assigned to any person or entity other than ASSIGNEE any right that is being assigned to ASSIGNEE herein.
