PATENT AND TRADEMARK SECURITY AGREEMENT

THIS PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of August 26, 2005 (this "Patent and Trademark Security Agreement"), by each of the parties listed on the signature pages hereof and those additional entities that hereafter become parties hereto by executing the form of Supplement attached hereto as Annex 1, as grantors (collectively, the "Grantors", and individually, each a "Grantor"), in favor of THE BANK OF NEW YORK, in its capacity as Collateral Agent for the Lenders (the "Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of the date hereof among the Lenders, the Bank of New York, a New York corporation, as administrative agent, and collateral agent, Salton, Inc., a Delaware corporation, with offices at 1955 Field Court, Lake Forest, Illinois 60045 (the "Parent"), each of the Parent's Subsidiaries identified on the signature pages thereof as borrowers (the Parent and such Subsidiaries are referred to hereinafter each individually as a "Borrower", and individually and collectively, jointly and severally, as the "Borrowers") and each of the Parent's other Subsidiaries identified on the signature pages thereof as guarantors (including all annexes, exhibits and schedules thereto and as from time to time amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders have agreed to make the Loans to the Borrowers;

WHEREAS, the Parent has previously executed that certain Amended and Restated Credit Agreement, originally dated as of May 9, 2003, as amended and restated and further amended, currently by and among the Parent, each of the Parent's subsidiaries identified on the signature pages thereof as borrowers, Wells Fargo Foothill, Inc., as First Lien Agent, Silver Point Finance, LLC, as First Lien Co-Agent, and the lenders thereto (the "First Lien Credit Agreement"); and

WHEREAS, pursuant to the requirements of the First Lien Credit Agreement, each of the Grantors has pledged all of its interest in the Patent and Trademark Collateral (as defined below) to secure all of the Grantors' obligations under the First Lien Credit Agreement and all of the agreements related thereto; and

WHEREAS, the Grantors wish to grant a lien in the Patent and Trademark Collateral in connection with the Credit Agreement; and

WHEREAS, the Agent has agreed to act as agent for the benefit of the Lenders in connection with the transactions contemplated by the Credit Agreement; and

WHEREAS, the First Lien Agent, First Lien Co-Agent and Agent have executed concurrently herewith an Intercreditor Agreement which sets forth certain agreements with respect to the relative interests of the First Lien Agent, and First Lien Co-Agent, on the one hand, and of the Agent, on the other hand, in the Patent and Trademark Collateral; and

WHEREAS, each Grantor is a party to the Credit Agreement, as either a Borrower or as a Guarantor; and

WHEREAS, the Agent and the Lenders are willing to make the Loans and to provide the other financial accommodations as provided for in the Credit Agreement, but only upon the condition, among others, that each of the Grantors shall have executed and delivered to the Agent, for itself and the ratable benefit of the Lenders, this Patent and Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. The following terms shall have the following respective meanings:

“Patent” means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all patents of the United States or any other country, all registrations and recordings thereof, and all applications for patents of the United States or any other country, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State or Territory thereof, or any other country; (b) all reissues, continuations, continuations-in-part or extensions thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

“Patent Licenses” means any and all rights under any written agreement now owned or hereafter acquired by any Grantor granting any right with respect to any invention on which a Patent is in existence.

“Trademark” means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof; (b) all reissues, extensions or renewals thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

“Trademark Licenses” means any and all rights under any written agreement now owned or hereafter acquired by any Grantor granting any right to use any Trademark.

All other capitalized terms used but not otherwise defined herein have the meanings given to them in Annex A thereto to the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN PATENT AND TRADEMARK COLLATERAL. Each Grantor hereby grants to the Agent, on behalf of itself and the Lenders, a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Patent and Trademark Collateral"):

(a) all of its Patents and Patent Licenses to which it is a party, including those referred to on Schedule I hereto;

(b) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule II hereto;

(c) all reissues, continuations or extensions of the foregoing;

(d) all goodwill of the business connected with the use of, and symbolized by, each Patent, Patent License, Trademark and Trademark License; and

(e) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement of any Patent or Patent licensed under any Patent License, (ii) infringement or dilution of any Trademark or Trademark licensed under any Trademark License, or (iii) injury to the goodwill associated with any Patent, Patent licensed under any Patent License, Trademark, or Trademark licensed under any Trademark License.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Patent and Trademark Security Agreement are granted in conjunction with the security interests granted to the Agent, on behalf of itself and the Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Patent and Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. NEW PATENT AND TRADEMARK COLLATERAL. If, prior to the termination of the Security Agreement, any Grantor shall (i) obtain rights to or become entitled to the benefit of any patent or patent application or any reissue, division, continuation, renewal, extension or continuation-in-part of any Patent or any improvement on any Patent, (ii) obtain rights to or become entitled to the benefit of any new trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks or service mark, applications, (iii) obtain rights to or become entitled to the benefit of any new license agreements, whether as licensee or licensor, or license renewals, or (iv) enter into any new license agreement, the provisions of this Patent and Trademark Security Agreement shall automatically apply thereto (to the extent permitted by licensors under agreements in connection with the granting of licenses under such agreements). Each Grantor hereby authorizes the Agent to modify this Patent and Trademark Security Agreement unilaterally (x) by amending Schedule I to include any future patents and patent applications that are Patents under this Patent and Trademark Security Agreement, or to include any future license agreements that are Patent Licenses under this Patent and Trademark Security Agreement (to the extent permitted by

licensors under agreements in connection with the granting of licenses under such agreements), (y) by amending Schedule II to include any future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications that are Trademarks under this Patent and Trademark Security Agreement, or to include any future license agreements that are Trademark Licenses under this Patent and Trademark Security Agreement (to the extent permitted by licensors under agreements in connection with the granting of licenses under such agreements), or (z) by filing, in addition to and not in substitution for this Patent and Trademark Security Agreement, a duplicate original of this Patent and Trademark Security Agreement containing on Schedule I thereto, as the case may be, such future patents, patent applications and future license agreements and containing on Schedule II thereto, as the case may be, such future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks, service mark applications and future license agreements.

5. INTERCREDITOR AGREEMENT. Notwithstanding anything to the contrary in this Patent and Trademark Security Agreement, (a) this Patent and Trademark Security Agreement, the rights of the Agent hereunder and the enforcement of the Agent's remedies hereunder, are subject to the terms and provisions of the Intercreditor Agreement and to the extent of any inconsistency between the terms of this Patent and Trademark Security Agreement and the terms of the Intercreditor Agreement, the terms of the Intercreditor Agreement shall govern and control, and shall be deemed to supersede the applicable inconsistent provisions of this Patent and Trademark Security Agreement and (b) until the Discharge of First Lien Indebtedness (as defined in the Intercreditor Agreement) shall have occurred, any obligation of the Grantors in this Patent and Trademark Security Agreement that requires delivery of Collateral to or possession of Collateral with, the assignment, endorsement or transfer of Collateral to or the registration of Collateral in the name of, the Agent shall be deemed complied with and satisfied if such delivery of Collateral is made to, such possession of Collateral is with, or such Collateral be assigned, endorsed or transferred to or registered in the name of, the First Lien Agent or the First Lien Co-Agent.






