ASSIGNMENT

AND WE HEREBY authorize and request the Director of the U.S. Patent and Trademark Office or any other proper officer or agency of any other region or country to issue all said Letters Patent to the ASSIGNEE;

AND WE HEREBY warrant and covenant that we have the full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict herewith;

AND WE HEREBY agree to communicate to said ASSIGNEE or its successors, assigns, or legal representatives any facts known to us respecting the improvements; to execute all

divisional, renewal, substitute, continuation, reissue, reexamination, or the like, or any international, regional, or non-U.S. applications; sign all lawful documents and make all rightful oaths and declarations relating to the improvements; and to testify in any judicial or administrative proceeding; and generally do everything possible to aid the ASSIGNEE to obtain and enforce said Letters Patent in the United States or any other region or foreign country when requested so to do by the ASSIGNEE.

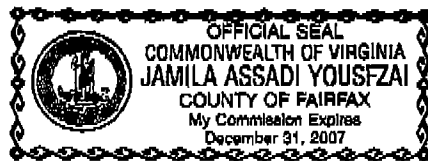
