
ASSIGNMENT

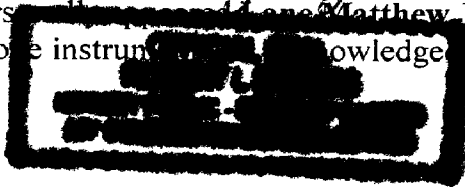


