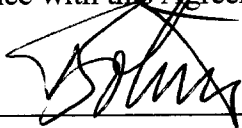

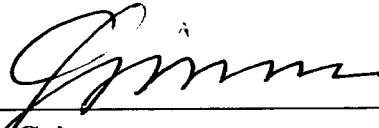
Patent therefor, and the Assignors hereby authorize and request the Commissioner of Patents to issue said Letters Patent to the Assignee in accordance with this Agreement.

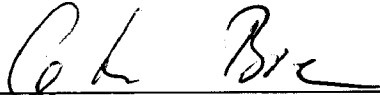

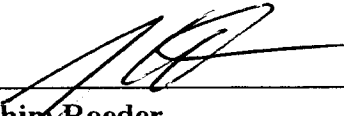
