4. The right to Assignee to file in its name applications for patents and like grants or protection for said Invention in any country or countries foreign to the United States; and

5. All international rights or priority associated with said Invention, said Application, and any other applications for patents, patents and like grants or protection on said Invention.



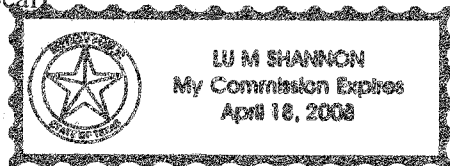


