Assignment of Patent Applications from

LUCENT TECHNOLOGIES, INC.

to

AT&T PARADYNE CORPORATION

Effective as of July 31, 1996, LUCENT TECHNOLOGIES, INC. ("Assignor"), a Delaware corporation, and AT&T PARADYNE CORPORATION ("Assignee"), a Delaware corporation, agree as follows:

1. Definitions

1.1 "Patent Applications" means the United States patent application no. 08/514040, filed August 11, 1995, and any and all divisional, continuation and continuation-in-part patent applications entitled to a filing date of that United States patent application.

1.2 "Foreign Counterpart Patent Applications" means any application for a patent, in a jurisdiction other than the United States, that claims priority, or that could claim or could have claimed priority if timely filed, from the Patent Application, whether already filed or to be filed in the future.

1.3 "Foreign Counterpart Patents" means any patent issued or issuing in a jurisdiction other than the United States, on a Foreign Counterpart Patent Application.

2. Assignment

2.1 In consideration of the sum of One U.S. Dollar (\$1.00) and other good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of all of which Assignor hereby acknowledges, Assignor assigns and transfers to Assignee all right, title and interest in:

2.1.1 the Patent Applications;

2.1.2 every patent, including any or all reissues, reexaminations, or extensions of patents, granted on the Patent Applications; and

2.1.3 all Foreign Counterpart Patents and Foreign Counterpart Patent Applications.

The foregoing shall include, without limitation, any and all rights pertaining to the Patent Application, Foreign Counterpart Patents and Foreign Counterpart Patent Applications under any international treaty, convention or agreement.

2.2 The assignment of Section 2.1 includes, without limitation, any and all rights to damages, profits or recoveries of any nature for past infringement, and royalties for all future use, of any and all patents and applications assigned, and any and all rights and privileges pertaining thereto.

3. Future Obligations

3.1 Assignor covenants that it will, whenever Assignee, or any of its successors, legal representatives and assigns, shall advise that any proceeding in connection with said Patent Applications, Foreign Counterpart Patents, Foreign Counterpart Patent Applications or any patent to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of Patent Applications, Foreign Counterpart Patents, Foreign Counterpart Patent Applications or any patent to be obtained thereon, without charge to Assignor, its successors, legal representatives and assigns, but at the cost and expense of the Assignee, its successors, legal representatives and assigns.
