



Whereas the Assignor has previously agreed to assign, and did assign title in and to the inventions and applications to the Assignee on or about May 23, 1993;

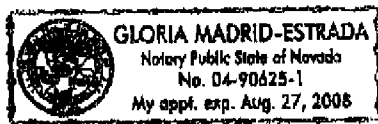
