## **RELEASE OF PATENT SECURITY AGREEMENT**

This RELEASE OF PATENT SECURITY AGREEMENT (this "Release") dated as of November 23, 2005 is by UBS AG, London Branch, the London branch of a Swiss corporation located at 1 Finsbury Avenue, London EC2M2PP England, as agent and trustee for each Finance Party to the Senior Credit Agreement and Mezzanine Credit Agreement described below (in that capacity the "Security Agent"), in favor of DYMO BVBA (formerly, Esselte NV), a limited liability company organized under the laws of the Kingdom of Belgium, located in Sint-Niklaas, Belgium (the "Company").

WHEREAS, the Company and UBS AG, London Branch as Security Agent, entered into a Security Agreement dated as of October 9, 2002 (the "Security Agreement").

WHEREAS, J.W. Childs Acquisition Sweden AB, the Security Agent and the other Finance Parties entered into the Credit Agreements (as defined in the Security Agreement) and the Company became a party to the Credit Agreements pursuant to an Accession Deed dated as of October 9, 2002;

WHEREAS, pursuant to the terms of the Security Agreement, the Company granted to the Security Agent a continuing security interest in and to certain of the assets of the Company including without limitation all right, title and interest of the Company in and to the patents on Schedule A attached hereto, to secure the Secured Liabilities (as defined in the Security Agreement) by a Patent Security Agreement (the "Patent Security Agreement"); and

WHEREAS, the Security Agent has duly authorized the execution, delivery and performance of this Release;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent agrees as follows:


SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.


SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent on behalf of the Finance Parties hereby assigns to and releases the Company from the lien on and continuing security interest in and to all right, title, and interest of the Company in and to the Patent Collateral (as defined in the Patent Security Agreement) including, without limitation, the Patent Collateral set forth on Schedule A hereto.

SECTION 3. Release of Patent Security Agreement. This Release has been executed and delivered by the Security Agent for the purpose of releasing the security interest of the Security Agent on behalf of each Finance Party in the Patent Collateral in the United States Patent and Trademark Office.
