ASSIGNMENT

WHEREAS, Hydromatix, Inc. ("Hydromatix") a corporation organized and existing under the laws of the State of California and having a place of business located at 10450 Pioneer Blvd., Building 3, Santa Fe Springs, California 90670 was the owner of various U.S. patents, pending U.S. patent applications, foreign patents, and pending foreign applications as more fully set forth in Exhibit A (the "Property").

Hydromatix further agrees to cooperate with BOC in the obtaining and sustaining of any and all such Letters Patents, but at the expense of BOC. BOC hereby acknowledges and accepts the sale, assignment and transfer of the same.

The Commissioner of Patents is hereby authorized and requested to issue the Letters Patent solely in accordance with the terms of this Assignment to BOC, its

successors, legal representatives and assigns of the entire right, title and interest therein.

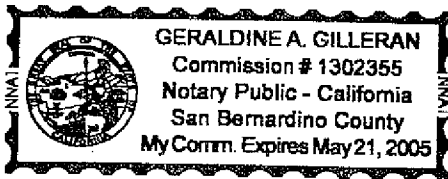
