A S S I G N M E N T

WHEREAS, I, BRUCE E. MEYER, of Port Charlotte, Florida, have invented certain new and useful improvements in PROTECTIVE GUIDE ASSEMBLY FOR A ROLL FORMING MACHINE, for which I am about to make application for Letters Patent of the United States, which application was executed on even date herewith; and

Upon said consideration, I convey to said Assignee the right to make application in its own behalf for protection of said invention in countries foreign to the United States and where expedient to claim under the International Convention or other international arrangement for any such application the date of the said United States application (or other application if any there be) in priority to other applications; and I do hereby covenant and agree with the said Assignee that I will at any time upon request, without further or additional consideration; but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said assignee may deem necessary or desirable to perfect the assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, renewal, reissued or extended Letters Patent of the United States or of any and all foreign countries on said invention. I agree with

the said Assignee that upon request, I will render all necessary assistance in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.
