These Articles of Amendment amend the Articles of Incorporation of Adaptive Micro Systems, Inc., a Wisconsin corporation (the "Corporation"), and are adopted pursuant to the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes. 3. The foregoing Articles of Amendment were submitted to the Corporation's shareholders by the Board of Directors of the Corporation and were adopted by such shareholders in accordance with Section 180.1003 of the Wisconsin Business Corporation Law.
4. The foregoing Articles of Amendment shall become effective as of the date of the filing of these Articles of Amendment with the Department of Financial Institutions of the State of Wisconsin.
