AND for the same consideration, the said assignor hereby covenants and agrees to and with the said assignee, its successors, legal representatives and assigns, that the assignor will, wherever counsel of the assignee or the counsel of its successors, legal representatives and assigns shall advise that any proceeding in connection with said inventions, or said Letters Patent or Patents, or in any proceeding in connection with Letters Patent for said inventions in any country, including interference proceedings, is lawful and desirable, or that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue or extension of any Letters Patent, to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary, required or desirable to be done for the filing, prosecution, assignment, maintenance, enforcement and defense of said Letters Patents for said

inventions, without charge to the said assignee, its successors, legal representatives and assigns, but at the cost and expense of the said assignee, its successors, legal representatives and assigns.
