## ASSIGNMENT

WHEREAS, I, **Nanci Schwind**, a citizen of the United States, residing at 11203 RR 2222 #1304, Austin, Texas 78730 (hereinafter referred to as "ASSIGNOR"), have invented a Photo Frame, for which I have executed an application for a United States Design Patent which was filed on April 28, 2005 as Application Serial No. 29/228,774; and
