Assignment of Invention and Patent Application

THIS AGREEMENT dated NOV 28 2005 is made BETWEEN:

UNITED EPITAXY COMPANY, LTD., a corporation incorporated under the laws of the Republic of China whose registered office is at 9F, No.10, Li-Hsin Rd., Science Park, Hsinchu, Taiwan, R.O.C. (hereinafter called "the Assignor");

2. Assignor authorizes and requests the Commissioner for Patents to issue any resulting patent(s) as following: 0% to Assignor and 100% to Assignee. (The singular shall include the plural and *vice versa* herein.)

3. Assignor hereby authorize and request the Patent and Trademark Office Officials in the United States and any and all foreign countries to issue any and all letters patent, when issued, to Assignee, as the assignee of my entire right, title, and interest in and to the invention, for the sole use and enjoyment of Assignee, its successors and assignees.

4. Further, Assignor agree that I will communicate to Assignee or its representatives any facts known to me respecting the invention, to testify in any legal proceedings, to sign all lawful papers, to execute all divisions, continuations, substitutions, renewal and reissue applications, and to generally do those things necessary to aid Assignee and its successors and assigns to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
