Assignment of Invention and Patent Application

THIS AGREEMENT dated NOV 28 2005 is made BETWEEN:

UNITED EPITAXY COMPANY, LTD., a corporation incorporated under the laws of the Republic of China whose registered office is at 9F, No. 10, Li-Hsin Rd., Science Park, Hsinchu, Taiwan, R.O.C. (hereinafter called "the Assignor");

AND
