PATENT ASSIGNMENT

WHEREAS, MARK IV INDUSTRIES LIMITED (hereinafter referred to as the "ASSIGNOR"), a corporation organized and existing under the laws of Canada, whose full post office address is 6030 Ambler Drive, Mississauga, Ontario, L4W 2P1, Canada, is the owner of all right, title and interest in and to certain intellectual property relating to information display systems and technology, including patents, patent applications, inventions, industrial designs, know how, confidential information and trade secrets, as identified in part in Schedule "A" attached hereto (all of which is hereinafter referred to as the "Intellectual Property Rights");

AND WHEREAS, MARK IV IDS CORP., a corporation organized and existing under the laws of Nova Scotia, Canada, (hereinafter referred to as the "ASSIGNEE"), whose full post office address is 6030 Ambler Drive, Mississauga, Ontario, L4W 2P1, Canada, desires to acquire from the ASSIGNOR, the whole right, title and interest in and to said Intellectual Property Rights;

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, the ASSIGNOR by these presents does hereby sell, assign and transfer to the ASSIGNEE, its successors and assigns, effective as of February 29, 2004, the whole right, title and interest in and to the Intellectual Property Rights for Canada, the United States of America and all other countries, including the right to sue for and recover damages for past infringements of the Intellectual Property Rights;

AND the ASSIGNOR hereby requests that any and all Letters Patent, Utility Models, Industrial Designs or other forms of protection for said Intellectual Property Rights be issued to the ASSIGNEE, its successors, assigns and legal representatives;

AND the ASSIGNOR hereby authorizes and empowers said ASSIGNEE, its successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent, industrial design, utility model, or other form of protection for the Intellectual Property Rights filed, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any


Convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from them, and the ASSIGNOR hereby assigns to said ASSIGNEE, all its said right to claim such priority in any country from said patent applications;

AND the ASSIGNOR agrees to do all such further and other acts and things as may be necessary or desirable to give full effect to this Assignment. In particular, without limiting the generality of the foregoing, the Assignor will duly execute, acknowledge and deliver to the Assignee, or cause to be executed, acknowledged and delivered to the Assignee, in form approved by the Assignee, any and all further assignments or instruments which the Assignee may deem necessary, expedient or proper to evidence the transfer of the Intellectual Property Rights by the Assignor to the Assignee or to protect, enforce, defend or confirm any of the Assignee's rights hereunder or otherwise to carryout and give effect to the purposes and intent of this Assignment;

AND the ASSIGNOR hereby authorizes and grants to the firm RIDOUT & MAYBEE LLP of One Queen Street East, Suite 2400, Toronto, Ontario, Canada, M5C 3B1, the power to insert or delete from the Schedule attached to this Assignment such identification of the Intellectual Property Rights as may be necessary or desirable in order to comply with the intellectual property regulations of any country for recordation of this document.


