Assignment

WHEREAS, We, the undersigned inventors, have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Method For Verifying The Integrity Of Thermal Desorption Sampling Tubes**, bearing Patent Application Serial No. 11/285,914 and filed on November 23, 2005;
