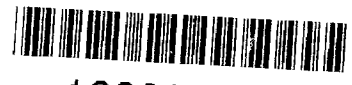



**MAKING AN OVERLAY IMAGE EDGE ARTIFACT LESS CONSPICUOUS**


