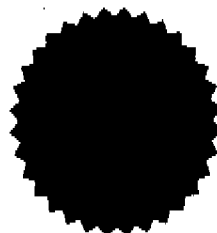

The name of this corporation is Archus Orthopedics, Inc. (the "Corporation")."

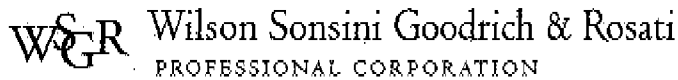
