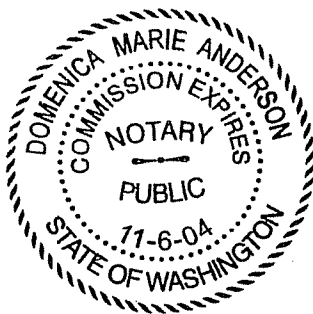
## ASSIGNMENT





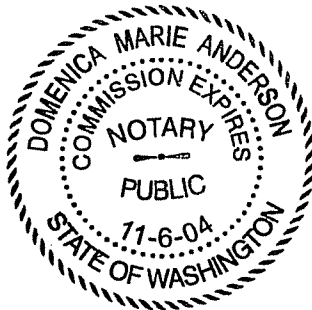
