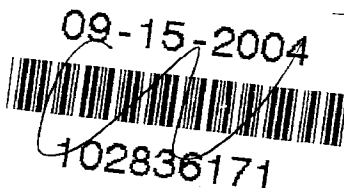

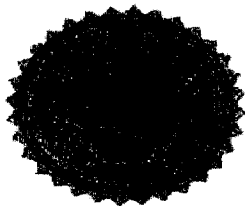


SECOND: The certificate of incorporation of the Corporation is hereby amended by deleting Article First thereof and substituting in lieu of said Article the following new Article:
