transfer any rights or interests inconsistent herewith; we bind ourselves to execute and deliver to NexTech Materials, Ltd., its successors and assigns, any further documents or instruments and to perform any further acts that may be deemed necessary to enable it, its successors and assigns, to file the said applications for letters patent for the said invention in any country in which it may elect to file such applications, and to vest in NexTech Materials, Ltd., its successors and assigns, the title herein conveyed and intended to so be conveyed, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to NexTech Materials, Ltd., its successors and assigns; and we further covenant and agree, that we will, upon request, communicate to NexTech Materials, Ltd., its successors and assigns, any facts relating to the said invention and the history thereof known to us, and that we will testify as to the same in any interference or other litigation when requested to do so by NexTech Materials, Ltd., its successors and assigns.



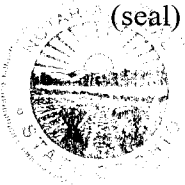

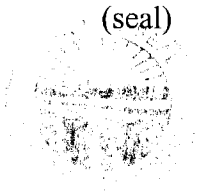
