## ASSIGNMENT

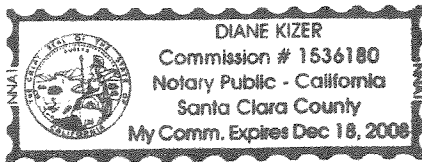


