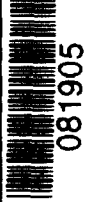

I request that any and all patents for said inventions be issued to said assignees, their successors, assigns, and legal representatives, or to such nominees as they may designate.




