Deed of assignment made at Melbourne on 30 April 2004

Kilda Road, Melbourne, Victoria, 3004 ("Assignee")

Recitals

- A. The Assignor and the Assignee are party to the Transfer Agreement.
- B. The Assignor is the owner of the Patent.
- C. Pursuant to the Transfer Agreement, the Assignor has agreed to assign the Patent to the Assignee.
- D. The Assignor hereby assigns to the Assignee, with effect from the Effective Time, all of the Assignor's right, title and interest in and to the Patent on the terms and conditions contained in this Deed.

Now this Deed witnesses

1. Definitions

"**Effective Time**" means midnight at the commencement of 16 March 2004.

"**Patent**" means the United States patent set out in the Schedule including the invention which is the subject of that patent.

"**Transfer Agreement**" means the Business Transfer Agreement dated 18 March 2004 between the Assignor (as transferor) and the Assignee (as transferee).

2. Assignment

In consideration of the payment by Assignee to Assignor of the sum of AU\$1.00, the sufficiency and receipt of which is hereby acknowledged, the Assignor hereby assigns to the Assignee, and the Assignee hereby accepts, with effect from the Effective Time:

- (a) all of the Assignor's right, title and interest in and to the Patent; and
- (b) all rights and immunities relating to, or arising, or to arise from the Patent, including all present and past rights to sue for infringement of the Patent.

3. Further acts

Each party must promptly do all further acts and execute and deliver all further documents (in form and content reasonably satisfactory to that party) required by law or reasonably requested by another party to give effect to this Deed.

4. Governing law and jurisdiction


