THIS MATTER, having come on before the Court by reason of a Notice of Motion filed by the Assignee herein, praying for the entry of an Order approving a private sale of substantially all of the assets of the within estate, per N.J.S.A. 2A:19-19, and it appearing that the Assignee has entered into an Asset Purchase Agreement with Mahi Networks, Inc. of Petaluma, California dated April 22, 2004 for the sum of _____, and the Court having reviewed the motions papers, and the petition submitted in support thereof, and good and sufficient notice of the within sale having been provided to all creditors and parties in interest and to other potentially interested buyers, and no competing offers having been received for the aforementioned assets, (or alternatively, no higher or better offers having been received) and the Court having heard the argument of counsel, as well as the testimony of William Gartner, and no objections to the motion being received by the Court, and the Court further

finding the assets to have been actively and sufficiently marketed, and the Court further finding that the Asset Purchase Agreement was negotiated and entered into in good faith as a result of arms length bargaining, and good cause appearing for making of this Order,

IT IS, on this 6th day of May, 2004,

ORDERED, that the Asset Purchase Agreement by and between Steven Z. Jurista, Assignee for the Benefit of Creditors in the above matter, and Mahi Networks, Inc. of Petaluma, California dated April 22, 2004 shall be and the same is hereby approved, and it is further

ORDERED, that the sale of substantially all of the assets of the within estate as identified in the Asset Purchase Agreement to Mahi Networks, Inc. for the purchase price of \$1,000,000 is hereby approved, and it is further


ORDERED, that the aforementioned sale shall be free and clear of all valid liens, claims and encumbrances, including, but not limited to, all liens, claims, security interests and encumbrances of Heller Financial Leasing, Inc., Silicon Valley Bank, Pentech Financial Services, Inc., Dominion Venture Finance L.L.C., ATEL Leasing Corporation, Kanakia Hamant, PFF Bank & Trust, Corporate Park Associates, GB, LLC and ArrayComm, Inc., any valid liens claims and encumbrances to attach to the proceeds of sale, and it is further


ORDERED, that the Assignee herein be and he is hereby authorized to execute any bills of sale or other documents to effectuate the terms of this Order, and it is further

ORDERED, that all proceeds of the sale shall be held in trust by Wasserman, Jurista & Stolz and that there shall be no disbursements of the sale proceeds from trust prior to the forty-sixth day after entry of the within Order or if the within Order is the subject of a timely

appeal, and it is further

ORDERED, that the Assignee herein be and he is hereby authorized to disburse to the Key Employees engaged per Order of this Court dated April 15, 2004, ten percent (10%) of the gross sale proceeds upon disbursement of the purchase price from escrow, in accordance with the proceeding paragraph.
