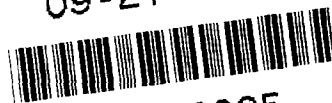

WHEREAS, I, Anders Lindqvist, a citizen of Sweden, reside at Stormgatan 27; S-26138 Landskrona; Sweden, and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Control And Power Supply Network For Vehicle Braking System**, bearing Patent Application Serial No. 11/128,764 and filed on May 13, 2005;


