
### ASSIGNMENT



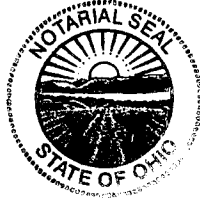


