confirm our obligation to and hereby sell, assign and convey, unto Assignee, its successors and assigns, except as set forth below, our entire right, title and interest -

(1) in and to an invention entitled SWITCH FOR POWER TOOL for which we have executed a United States patent application on even date herewith, said United States application being assigned U.S. Serial No. _____, filed _____
_____ (we hereby authorize Assignee to insert the serial number and filing date in the preceding blanks);


