
WHEREAS, **Lightpath Technologies, Inc.**, a Delaware corporation, hereinafter referred to as Assignee, is desirous of acquiring the same;

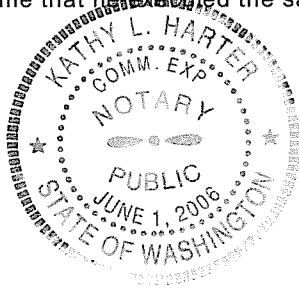
