additional papers which may be requested by said Assignee to fully carry out the terms of this Assignment;

AND, the Commissioner for the U.S. Patent Office is hereby authorized and requested to issue any Letters Patent to said Assignee in accordance with the terms of this Assignment.

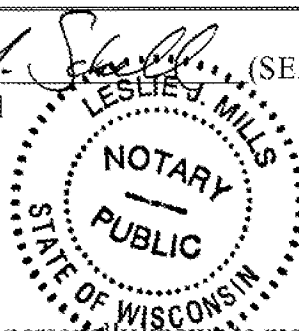

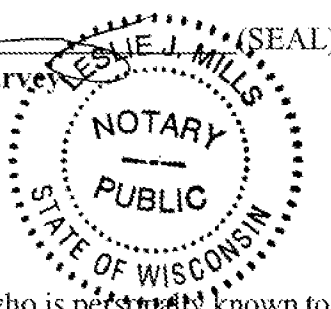
