- (iv) in this paragraph (a), are sometimes hereinafter individually and/or collectively referred to as the "Released Patents");
- (b) all rights under or interests in any patent license agreements with any other party, whether Grantor is a licensee or licensor under any such license agreement, including, without limitation, those patent license agreements listed on Exhibit A attached hereto and made a part hereof, and the right to prepare for sale and sell any and all Inventory now or hereafter owned by Grantor and now or hereafter covered by such licenses; and
 - (c) all proceeds of the foregoing.
- 2. Agent hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Released Patents.
