I, **AUSTIN TIMOTHY RYAN** of 27 Stawell Road, Horsham in the State of Victoria, Inventor  
HEREBY REVOKE all former Wills and Testamentary dispositions heretofore made by me and  
declare this to be my last Will.

1. I APPOINT my son **PAUL EDWARD RYAN** and my Solicitor **NICHOLAS JOHN LUCAS** of 16A Darlot Street, Horsham to be Executors of this my Will and Trustees of my Estate (hereinafter called "my Trustees").
2. I DECLARE that my Trustee being a Solicitor or other person engaged in any other profession or business may act in a professional capacity and shall be entitled to charge and be paid for all professional or other charges for any business act done by him or her firm in connection with trusts hereof including acts which a Trustee could have done personally AND I AUTHORISE my Trustee to charge commission at such rate or rates not exceeding those charged by Trustee Companies in estates of like value at the date of my death.
3. I EXPRESS THE WISH that my funeral service be arranged by W B Gardiner & Sons of Warracknabeal and following my funeral service that I be buried at the Horsham Cemetery.
4. I GIVE AND BEQUEATH the following:
  - (a) to my granddaughter **CASSANDRA RYAN** my piano absolutely;
  - (b) to my grandson **TOBIAS RYAN** my billiard table and the sum of FIVE HUNDRED DOLLARS (\$500.00) together with a keepsake of his choice of my personal chattels.
5. I GIVE AND BEQUEATH to my Trustees the sum of TWO HUNDRED AND FIFTY DOLLARS (\$250.00) to pay the Parish Priest for the time being of the **CATHOLIC CHURCH** at Horsham for saying masses for the repose of my soul and I DIRECT that the receipt of the Treasurer or other proper officer of the Catholic Church be a full and sufficient discharge for my Trustees in respect hereof.
6. I GIVE DEVISE AND BEQUEATH the remainder and residue of my estate both real and personal wheresoever and whatsoever unto my Trustees UPON TRUST:
  - (a) To pay thereout all my just debts funeral and testamentary expenses and all duties (if any) on my estate:

- (b) To hold the balance for my wife **DOREEN ROSE RYAN** absolutely. I EXPRESS THE WISH that after my death my said son **PAUL EDWARD RYAN** take care of my wife **DOREEN ROSE RYAN** and attend to her needs where ever possible;
- (c) In the event the said **DOREEN ROSE RYAN** shall predecease me then to pay the balance to my said son **PAUL EDWARD RYAN** absolutely.

7. IN THE EVENT of my said son **PAUL EDWARD RYAN** predeceasing me and leaving a child or children who shall survive me then such child or children shall take equally per stirpes the share in my estate under this my Will to which my deceased son would have been entitled had he been living at the time of my death.

8. I DIRECT that my Trustees shall have the following powers:

- (a) to postpone the sale or conversion of the whole or any part of my estate for such period as my Trustees shall think fit and to retain as authorised investment of my estate any assets (including shares in companies) which I may own at my death;
- (b) to apply the whole or any part of the income or capital of the share to which any infant may be contingently or otherwise entitled under this my Will to or for the benefit of such infant and Sections 37 and 38 of the Trustee Act 1958 shall be deemed to be extended accordingly.
