ASSIGNMENT

WHEREAS, Anthony Petronelli, a citizen of the United States of America, residing at 49 Mountain View Avenue, San Jose, California, 95127; hereinafter called the "Assignor", have made the invention described in the United States patent application entitled "Service Provider Identifier", Attorney Docket No. SBC-1037-US (SBC NW1056), for a full description of which reference is here made to an application for Letters Patent of the United States filed on July 15, 2005 and assigned Application Serial No. 11/182,895; and

WHEREAS, SBC KNOWLEDGE VENTURES, L.P., a partnership organized and existing under the laws of the State of Nevada, having a place of business at 645 E. AND said Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent application identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignor will execute and deliver to the Assignee to carry out the terms of this Assignment. Assignor authorizes attorney or agent to fill in the U.S. Application Serial No. above, if required.

AND said Assignor authorizes and requests the Commissioner of Patents to issue Letters Patent on said application, and on any all divisions and continuations thereof, to said Assignee, its assigns and legal representatives, in accordance with the terms of this Assignment.
