FOR VALUE RECEIVED, We, MIKKO RINNE and CARL EKLUND, citizens of Finland, and residing at Tallbergin puistotia 1 C 25, FI-00200 Helsinki, FINLAND and Stahlbergintie 3 E 48, FI-00570 Helsinki, FINLAND, respectively, hereby sell, assign and transfer to NOKIA CORPORATION, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in a IN-BAND SET-UP AND CONFIGURATION OF TRANSFER-RELATED RESOURCES, which is described in an application for Letters Patent of the United States, Serial No. 11/181,691 filed July 13, 2005; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We request that any and all patents for said inventions be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.
