AGREEMENT to WAIVE PROMISSORY NOTE OBLIGATION

This AGREEMENT, is herein made this 5th day of July, 2005, by and between **Robert Evans** (Party of the First Part), and **Lawrence Tony Mitchell**, (Party of the Second Party).

- A. WHEREAS:** Jon (Jack) H. Harris was inventor of and holder of U. S. Patent No. 5,515,633 for a Firearms Trigger Shield. Patent issued May 14, 1996.
- B. WHEREAS:** A BILL OF SALE was granted by Jon H. Harris for a TRIGGER SHIELD INVENTION (per reference above). On April 28, 2003, and was paid, or was to be paid as follows:
- C. WHEREAS:** A \$50,000 Promissory Note was given to Jon (Jack) H. Harris by Robert Evans as Trustee for E & M Shield Corporation on April 28, 2003. \$10,000 cash was paid at time of issuance of Promissory Note as initial payment, with the balance of \$40,000 to be paid within 6 months (October 28, 2003).
- D. WHEREAS:** The E & M Shield Corporation was incorporated April 28, 2003, with Evans, Robert, listed as DP; Mitchell, Tony L. Listed DV; and Evans, Ramona, listed as DS.
- E. WHEREAS:** additionally, a Last Will and Testament was drafted, signed, and notarized by Jon (Jack) H. Harris on April 28, 2003, (6:58PM) conveying ownership of the stated Patent and the outstanding Promissory Note, to Lawrence Tony Mitchell (Grantee) in the event his death occurred within the next six (6) month period of time, and the full balance of the note remained un-paid.
- F. WHEREAS:** Mr. Jon H. Harris died May 12, 2003, 14 days after the date of the Will and the conveyance of the Patent, and within the 6-month stipulated period in the Will.
- G. WHEREAS:** today the Promissory Note is currently held in abeyance wherein the issuer of the Note has made no further payments (beyond the initial payment), leaving the \$40,000 amount outstanding since date of issuance.

NOW THEREFORE: Lawrence Tony Mitchell, Grantee of the bequeathed Promissory Note, monies, property, and rights, as given and granted in the Last Will and Testament of Mr. Jon H. Harris, Grantor, herewith forgives, waives, and resigns the payment of the \$40,000 outstanding obligation of the Promissory Note of April 28, 2003, upon the acceptance by Robert Evans of the two (2) instruments attached hereto:

1. Recordation Form Cover Sheet - PATENTS ONLY - USP&TO
2. Tony Lawrence Mitchell resignation certification from the E & M Shield Corporation

Any claim which may be laid upon the \$40,000 by any other party will be assumed and defended by Lawrence Tony Mitchell

The completion of this transaction now and forever bars and waives any obligations, commitments, agreements now or ever, existing between either the Party of the First Part, Robert Evans, and the Party of the Second Part, Lawrence Tony Mitchell.

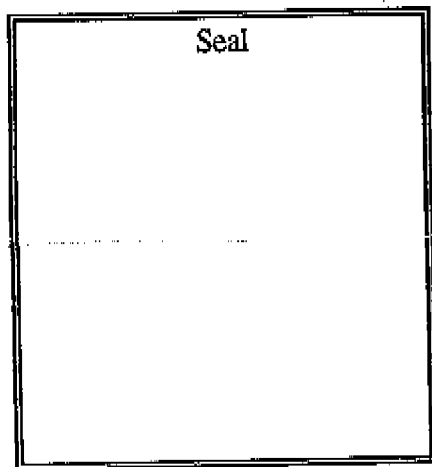
