ASSIGNMENT OF UNITED STATES PATENT APPLICATION


WHEREAS, we, **Ian C. Goodall** and **Malon S. Updike**, of Ontario, Canada and Dayton, Ohio, respectively, have invented certain new and useful improvements in **METHOD OF CREATING A SUBSTITUTE CHECK USING CHECK IMAGE DATA FROM A REMOTE CHECK IMAGE CAPTURE DEVICE AND AN APPARATUS THEREFOR**, Docket No. 12217.00, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and


